- 2. The Series A Convertible Preferred Stock has no expiration date, and shall convert into shares of common stock, par value \$0.001 per share, of Gemphire Therapeutics Inc. (the "Company") on a one-for-one basis immediately prior to the closing of the Company's initial public offering.
- 3. The notes were issued in the original principal amount of \$200,000. The outstanding principal and accrued interest on such notes will automatically convert into shares of common stock, par value \$0.001 per share, of the Company immediately prior to the closing of the Company's initial public offering. The notes bear interest at a rate of 8% per annum. The notes have accrued interest of \$13,348 to date and will continue to accrue interest until conversion.
